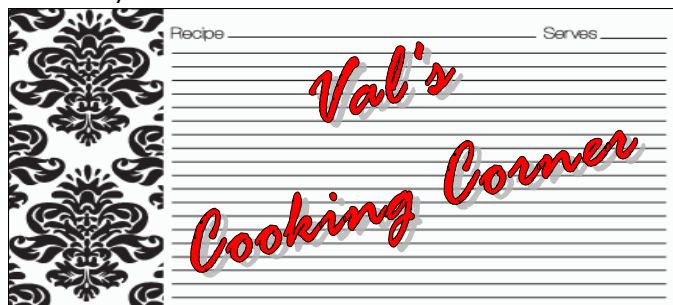

Super Bowl Sunday is upon us so I am appropriately sharing a few simple game day snacks. All are easy and crowd pleasers. Toss them together, call a few friends, fire up the big screen and enjoy the game.....

## FIRE CRACKERS

1 pound mini crackers (any combination of mini cheese, mini club, & mini saltine)  
1 ½ cups canola oil  
1 pkg ranch dressing mix  
2-3 tablespoons crushed red pepper  
Mix oil, ranch dressing mix, and crushed red pepper and pour over crackers in airtight container. Toss several times over a 1 hour period. Best if made day ahead. Will keep for an extended period. Do not refrigerate.

## PEPPERONI PIZZA SPREAD

2 cups shredded mozzarella cheese  
2 cups shredded cheddar cheese  
1 cup mayonnaise  
1 cup chopped pepperoni  
1 can mushrooms, drained  
½ cup chopped onion  
½ cup chopped green pepper  
1 cup chopped ripe olives  
1 cup chopped stuffed green olives  
Preheat oven 350 degrees. Mix all ingredients in a 9X13 baking pan. Bake 25-30 minutes. Serve with breadsticks, tortilla chips or toasted baguettes.

## SPINACH AND ARTICHOKE DIP

8 ounces cream cheese  
16 ounces of sour cream  
½ cup butter  
1 ½ -2 cups shredded Parmesan cheese  
14 ounces quartered artichoke hearts, drained and coarsely chopped  
4 ounce can diced jalapenos, drained  
10 oz frozen spinach (thawed and drained)  
2-3 garlic cloves, pressed  
In a medium pot over medium heat, melt cream cheese, sour cream, butter and parmesan cheese, stirring frequently until melted and an even consistency. It should start to bubble. Stir in artichokes, jalapenos, spinach and garlic. Serve hot with chips, crackers or toasted baguettes.





## JALAPENO POPPER DIP

8 jalapenos, halved and seeded  
1 tablespoon olive oil  
2-8 ounces cream cheese  
1 cup sour cream  
1 cup shredded cheddar cheese, divided  
1 cup crushed tortilla chips  
Preheat a broiler or grill to medium-high.  
Toss the jalapeño halves with the EVOO  
and roast under the broiler or char on the  
grill until softened and blackened, about  
3 minutes per side.  
Turn the oven to 400°F. Let the peppers  
cool enough to handle and chop.  
In a large mixing bowl, combine the  
cream cheese, sour cream, half of the  
cheddar and all of the chopped roasted  
peppers. Transfer the mixture to a baking  
dish and top with the remaining shredded  
cheese and crushed chips. Bake the dip  
until golden brown and bubbly, 15-18 min-  
utes. Serve with assorted chips or toasted  
baguettes. Note: you may substitute  
canned jalapenos for the roasted ones or  
chop the fresh ones and sauté until soft in  
a little olive oil.

### A NOTE FROM THE EDITOR:

In our last edition of *The Westby Border News* we began a two-part article written by Raynard Huglen. Below is the conclusion of his article.

#### WESTBY BOYHOOD MEMORIES

(Continued)

The 25<sup>th</sup> anniversary of the founding of Westby took place in the summer of 1939. It was a great occasion with a big parade including the American Legion men marching and those early day automobiles. An outdoor program was held in the skating rink area and a bandstand of several levels was built into the natural embankment. Mr. John Hodgson, a farmer and Presbyterian minister gave a talk. The only thing I remember him saying was the term "rugged individualism". I did not know what it meant, but it sounded strong. I can see now he was describing the spirit of the pioneers who settled the Westby area. For someone who has had a lifelong love affair with books, the National Youth -

Administration, NYA, library in the Ford garage was a wonderful place to spend time. In the south end of the showroom (we thought the Ford Garage a handsome place) a library had been set up as one of the government projects of the great depression. The librarians were mostly girls out of high school and the library books were a good supplement to what was available in school.

One of the great excitements of 1939 was the building of the new highway in to town from the west. The next year it was paved. In the final mile into town, we all watched the progress carefully as it extended even up Main Street.

Among our parsonage neighbors were Hjelms and Carl Neresons. We carried our water from the Nereson pump. The Hjelms kept a cow on the Ed Lien farm southeast of town. (The farm was later occupied by the Erling Tangedahls for many years.) My brother, Erling, and I would sometimes walk out there with Eddie or Leslie for the evening milking. Both Eddie and Leslie were basketball players and they had a bottomless pail nailed on the west side of their garage. We all played ball, shot baskets, and played other games using any kind of ball and this bottomless pail. Leslie would later go away to CCC camp before returning home, and Eddie would have a body shop in Helena.

# School Board Meeting Minutes

Regular Meeting

January 10, 2013

7:30 P.M.

The Regular Meeting of the Board of Trustees of Westby School District 3 was held on January 10, 2013. Vance Meyer, Jim Sundsted, Aldon Joyes, Mr. Holecek, Mr. Somppi and Donna Sorenson were in attendance. Vice-chairman Meyer called the meeting to order at 7:38 p.m.

There were no visitors at the meeting.

Donna read the minutes of the December 12, 2012 meeting. Following no corrections or additions, these minutes were approved and placed on file.

The Board reviewed the Clerk's November financial report.

**Public Comment:** None

## **Committee Reports:**

**Buildings & Grounds:** Mr. Holecek presented an advertisement for solicitation of bids for the school re-roofing project. Following discussion Joyes moved to approve the advertisement pending approval by the school's attorney, Sundsted seconded the motion; AIF.

**Sports Co-op Committee:** Mr. Holecek reported that things are going well for the sports co-op. The schools have been doing a good job of coordinating schedules and communicating with students and parents. The committee is trying to coordinate holiday and school breaks for the 2013-14 school year that are common to both schools.

## **Unfinished Business:**

**A.** New Policy 8500 (School Owned Housing) was presented for a second reading. Sundsted made a motion to approve this policy, Joyes seconded; AIF.

**B.** Revised Policy 7400 (Credit Card Use) was presented for a second reading. Meyer moved to approve this revision, Sundsted seconded and all voted in favor.

## **New Business:**

**A.** Mr. Holecek explained to the board that more than 28 days have passed since posting Form 470, requesting competitive bids for e-rate services. Several bids have been received. The school's E-Rate coordinator, Jack Sterling, has recommended accepting the bid received from Nemont. -

Joyes made a motion to follow Mr. Sterling's recommendation and accept the bid received from Nemont, Sundsted seconded the motion, AIF.

**B.** Mr. Holecek advertised the Assistant Administrator position in-house, and discussed it with all the teachers at a teachers meeting. He received a letter of interest in the position from Mr. Olson. Mr. Holecek recommended awarding the position to Mr. Olson with the wage/stipend to be determined by the board. Meyer made a motion to hire Mr. Olson as the Assistant Administrator, following Mr. Holecek's recommendation, Sundsted seconded; AIF.

**C.** Mr. Holecek reported that we will wait until March to receive the insurance renewal rates from MUST. Indications are that the state-wide pool renewal rates will be more favorable than the co-op renewal rates so MUST is allowing the co-op to take advantage of the best rate structure.

**D.** Mr. Meyer reported that the negotiating committee had compiled the information from the Superintendent evaluation forms they had received from board members and discussed this information with Mr. Holecek.

Based upon the favorable results of the evaluation, he recommended extending Mr. Holecek's current contract, which is due to expire on June 30, 2014, one additional year, to June 30, 2015.

He also recommended a paying 2% stipend for the 2012-13 school year based on the increase to base wages the teachers received this year. Mr. Holecek's salary for 2013-14 will be determined following teacher negotiations this spring. Meyer moved to extend Mr. Holecek's contract to June 30, 2015 and accept the additional recommendations of the negotiations committee, seconded by Joyes; AIF.

## **Announcements/Discussion**

**A.** Superintendent's Report:

Mr. Holecek informed the board that he and other area superintendents have met with law enforcement representatives to discuss options for increased school security. He is considering changing the bus drop-off zone, and limiting entry to the premises to one door during the school day.

The Ranger bus is still having on-going issues with the defrost system. Mr. Holecek is exploring options for repairs.

The condensers on the outside heat units on the west end of the school have been freezing up, so tents have been put over them and propane heaters used to thaw them. Mr. Holecek will send letters to Mon-Dak and Prairie Engineering requesting their attendance at the next board meeting to discuss what needs to be done to resolve this and other on-going issues.

Mr. Holecek updated the board on school funding bills that will be considered during this legislative session.

## B. Correspondence:

Thank you cards were read from the family of Joy Duffield (Teena Holecek's Mother) for the memorial, Shari Olson for the gift certificate she -

received following her surgery, and from Suzi Ekness, Cindy Stenehjem, Sonja and Darrell Mangel, Gayle Overgaard, Karla and Don Christensen and John and Arlene Hove for the Christmas dinner and gift certificates.

Sundsted moved to approve payment of January payroll warrants #11014-11022 and January claims warrants #17236 - 17269. Meyer seconded the motion for payment approval, AIF.

The November and December Extracurricular Financial Reports were reviewed followed by a motion by Meyer to approve; Joyes seconded the motion, AIF.

The meeting was adjourned at 8:50 p.m.

## ADVERTISEMENT FOR BIDS Re-Roofing Project Westby School District #3

The Board of Trustees of the Westby School District #3, in Westby Montana, is receiving sealed bids for re-roofing designated areas of the school facilities roof. All bids should be sealed and marked "Westby Schools Re-Roof Bid" and bids must be received by **4:00 P.M. on Monday, February 11, 2012** at the office of the Superintendent. Bids will be opened publicly at the regular Board of Trustees meeting at 7:00 p.m. on the 11<sup>th</sup> of February, 2013 in the Westby School Conference Room.

As a requirement of the bid process, a walk-through for all interested contractors will take place **between Monday, February 4, 2013 and Thursday, February 7, 2013** at the Westby School. Contractor representatives should schedule an appointment by contacting the Superintendent's office.

Bidding shall be open to contractors with a current Montana Contractor's

Registration Number and seven years or more experience with specified roofing

systems. Contractors shall comply with all fair labor practices and must meet the requirements of State and Federal Statutes. Each bidder will be required to be

properly licensed with the State of Montana.

Each bid shall be accompanied by bid security in an amount of no less than Ten Percent (10%) of the total amount of the bid. Acceptable forms of security are cash, cashier's check, certified check, bank money order, bank draft, bid bond, guaranty bond, or surety bond. Proof of liability coverage in the amount of no less than \$1,000,000 will be required. If awarded the contract, the bidder shall within **Ten (10) days** enter into formal contract.

The bid security of those bidders whose bids are not accepted will be returned.

## WESTBY BOYHOOD MEMORIES

*By Raynard Huglen*

*(Continued)*

Eugene Bundt was my best friend and we roamed far and wide in those years. There wasn't a corner of town we didn't explore. We drowned gophers on "east hill" (east of Liens's). We walked to the slaughter house by the dump ground and alkali lakes. We climbed the cuts on the new highway west of town and crawled through a culvert under the new highway. There was one close to town we could even stand up in. We tobogganed with classmates on "north hill" and sledged on the Lutheran Church hill and the longer one by Elmer Hultgrens, west of the school. Other classmates included Audrey Leininger Anderson, Jimmy Nordhagen, Lucille Danielson, Clifford Meyer and Jeanne Bergh Boulds.

Other things that come to mind of my boyhood memories include how thrilled we were at Christmas time by the toy display in the Gamble's Store and even the lesser collections of things for children in Miller Hardware and the Drug Store. One year, at least, there was a band day in town which brought much festivity. I remember the fashion of the day for boys was boots and breeches and the aviator cap. I remember the mystery of the jail house east of Main Street and how the boy scouts made use of it one day by taking over the town government.

My Dad passed away just over a year after we arrived in Westby from untreated diabetes in November of 1938. He died in the Ambrose hospital at the age of 52. The doctor in Ambrose was Dr S. Weeks.

Dad's death brought many changes for us. We did end up staying in Westby for another two years before returning to my Mother's home community of Newfolden, Minnesota. We were allowed to stay in the parsonage free of charge until the following summer when a new pastor came.

The pastor was O. J. Haukeness, a boyhood comrade of Dad's in Norway.

When we left the parsonage we moved to a house a block west of the IGA Store and Customs Office corner on Main Street. The house located down below the hill, was owned by the Hammer family and quite fittingly became known to us as "the Hammer House". We shared a water well with the Timbrels to the north. Times were tough, but the people were kind. Two ladies from the Birthday Club made weekly visits to our Mother each week in her bereavement. It was a great encouragement to her. We survived on \$24.00 a month from Aid to Dependent Children in the beginning with house rent costing \$12.00. Sometime later the allotment was raised to \$36.00 per month which still wasn't much for a family of four. Unexpected gifts of kindness from Westby residents helped us get through. We moved in August of 1940 and it would be 13 years before I would see Westby again when I came to Medicine Lake to be a pastor there. I pay tribute to Westby, One of the places I call home.

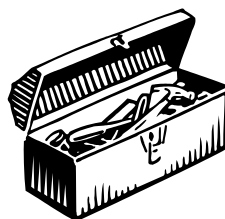

## DO NOT CALL NOTIFICATION FROM NEMONT TELEPHONE COOPERATIVE, INC., dba NEMONT

The Federal Communications Commission, FCC, and the Federal Trade Commission, FTC, have established a National Do-Not-Call Registry to address consumer concerns about unwelcome telemarketing calls.

You can register your residential phone number and wireless phone numbers on the Do-Not-Call Registry for FREE by calling 1-888-382-1222. You must call from the telephone(s) you wish to register.

You may also register via the Internet at [www.donotcall.gov](http://www.donotcall.gov). Inclusion of your phone number(s) on the National Do-Not-Call Registry will be effective three months following your registration.

With the exception of certain non-profit and political organizations, the registry applies to all telemarketers and covers both intrastate and interstate telemarketing calls. Commercial telemarketers cannot call you for five years if your number is listed on the registry.

Once the five years have passed, you may re-register your phone number(s). You may also remove your number(s) from the registry at any time.

The registry will not prevent all unwanted calls and does not cover the following:

- Calls from organizations with which you have established a business relationship.
- Calls for which you have given prior written consent.
- Calls which are not commercial or do not include unsolicited advertisements.
- Calls by, or on behalf of, tax exempt non-profit organizations.

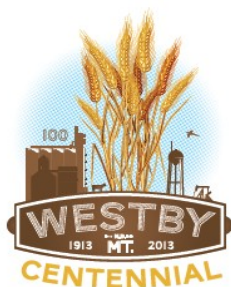
